This includes recommending action to governmental bodies and responding to proposals for residential and commercial development or liability within the Midtown Phillips neighborhood; 3) The safety and personal integrity of all individuals living, working, and visiting within Midtown Phillips Neighborhood.

damage to property, looting, burglary, destruction, and fires. The trauma experienced was real and is still fresh a year later. Empty lots, rubble, and boarded businesses of our minority family businesses are also still present a year later. The murder of George Floyd escalated the ever-present inequities of our community, but as the unrest grew and became more violent, the resilience and strength of our community also grew. Residents and organizations took to the street to support and protect our businesses and homes, organized clean-ups each day to assist impacted businesses, and stood in solidarity with each other on issues of police reform, business trauma, and imposed economic reality. Both the pandemic and the riots created serious hardships for our businesses. The destruction of Lake Street left our community without 3 post offices, no grocery stores, no Target or dollar stores, no library, no restaurants, no convenience stores, and no gas stations. 200 units of much-needed affordable housing were burned to the ground. Our Community Safety Center, built and developed in 2005 through our Phillips Weed & Seed Initiative, was burned to the ground along with all of our event gear stored inside with no insurance coverage. Hundreds of minority businesses were damaged, and thousands of people were without work. Metro Transit shut down busses and trains. We were isolated, non-mobile, trapped. Organizations from within and outside of our community brought in food and needed supplies. They organized volunteer clean-up crews. Mutual aid stations were set up throughout Midtown Phillips. Residents connected with each other to share contact information, blocks looked out for each other, and the American Indian community organized over 300 volunteers to protect our commercial corridors - Franklin Avenue, Bloomington Avenue, and parts of Lake Street. Partnerships developed over decades pulled together to help each other and community. Block networks built over decades developed communication networks to inform each other, be prepared, and support and help each other as needs arose. Being in the flames, it felt like a war. Surviving the week of impact and then these months to follow has resulted in pain, trauma, and unresolved PTSD. Community felt abandoned by the city with little, if any, direct communication, but we had each other to lean on and build our own networks, ways to gather information, to be informed, and ways to support each other. All of this on top of a growing pandemic, the Governor's executive orders, severe economic impacts from required business and social health restrictions, and an ongoing push to promote social distancing, masks, and eventually vaccines. MPNAI developed a resource page on its website. Then we increased our e-newsletter from one time per month to a distribution two times per month due to the amount of and ever-changing and updated information. Our Facebook page at one point went viral during the unrest with 370,000 hits on one of our posts regarding Lake Street and Chicago Avenue. As the demolition and rebuilding initiated, we began a virtual series called 'Lake Street Recovery' where we interviewed businesses about their experiences before, during, and after the destruction of their businesses. This series is recorded and available on our website. Virtually, we created forums to keep people talking, processing, and coming up with policy statements and projects. Our outreach partners were invaluable during this time. Banyan Community continued with monthly block network forums featuring speakers and an ability to speak to what we had all gone through and how to process. Semilla Center for Healing and the Arts continued to host outdoor art making sessions to pull people together, to talk, and to process. Coach Abdul from the New American Youth Soccer Club now owns and operates a security company. They were present on our corridors during and after the civil unrest. Somali TV and our community radio stations KRSM and KALY Radio were on top of getting crucial resource information out, as well as health mandates announced from the State Department of Health, business resources, and rental assistance. KRSM also conducted interviews of people in the community. Those were presented as a feature of our annual meeting in February 2021 and are available on the home page of our website: midtownphillips.org. We partnered with houses of faith, along with several local art, businesses, and cultural organizations, such as Heart of the Beast Puppet & Mask Theatre, Bethlehem Baptist, and St. Vincent de Paul, and ensured that there were always food and supplies available to those in need. There were constant heartwarming moments to see our community move into emergency mode and provide whatever was needed, whenever it was needed. Community advocacy groups continued protests for justice for Mr. Floyd, changes in policing and safety strategies, and hosted conversations on what safety looks like. Conversations led to advocacy for prioritization for funding needed to address root cause needs. MPNAI continued its work with and in partnership with the Minneapolis Police Department through interaction with our community crime prevention specialist. Lake Street Council hosted forums with businesses and the criminal justice team to include City, County, State, and Federal resources to address violent crime, narcotic and sex trafficking, ongoing damage to businesses, and an unsafe environment, further victimizing businesses by this impact on their customer base. We participated in meetings on public safety held by CM Cano, and a weekly Phillips Neighbors meeting started up virtually between East Phillips and Midtown Phillips on safety concerns and solutions. We invited resource people into those discussions to include American Indian CDC, 3rd Precinct Inspector Sean McGinty, Crime Prevention Specialist, and Al Bangoura, Superintendent of the Park Board. Also, during this period, encampments began to build along the Midtown Greenway, in City-owned vacant lots, and along public sidewalks. For the Midtown Greenway, neighbors and organizations along the Greenway worked with Hennepin County, holding weekly meetings with key staff. Outreach and resource teams worked with each resident of the encampment to ultimately find housing and services to enable a move out of a tent. By December, housing was available for everyone along the Greenway thanks to new housing facilities opened by AVIVO, Red Lake, and American Indian CDC. The County offered transportation to help people move and storage units for their belongings. Anything removed from the Greenway was tagged, labeled, and stored in case someone came looking for it at a later time. During periods of escalating crime, drug and sex trafficking, both Hennepin County Sheriff and the Park Police provided patrol. Outreach teams and law enforcement ensured safety of the residents in the encampment as well as the community from the potential of exploding propane tanks which had been collected and large bonfires adjacent to the propane tanks. While resources and housing were being found, the County and City placed porta potties and trash receptacles on site and weekly did a clean-up of the corridor. Block residents worked with the City of Minneapolis, CPED, outreach workers, and

Minneapolis police on encampments on city-owned land - 2600 14th Avenue, 2400 13th Avenue, Speedway, and 2600 Block of Bloomington Avenue (both sides of the street). Residents also monitored theft reports from businesses and homes, a consequence of the escalating street-based drug and sex trade. These challenges, needs, issues, and community work roll right into 2021 and are expected to continue to be a full-time focus well into the future. Community building, policy advocacy, and advocacy for adequate resources to address community needs will continue to direct the work of MPNAI.
